- NO FOOD OR DRINK CONTAINERS ALLOWED WITHIN 4 FEET OF THE POOL (WET DECK).
- NO POOL FURNITURE WITHIN 4 FEET OF THE POOL (WET DECK).

ALLOWED IN THE POOL:

- PERSONS 15 YEARS OLD OR YOUNGER MUST BE SUPERVISED AT ALL TIMES BY AN ADULT OVER 18 YEARS.
- SWIMWEAR ONLY CAN BE WORN IN POOL.
- BABIES REQUIRE SWIM DIAPERS AND MUST BE SUPERVISED BY AN ADULT AT ALL TIMES.
- FOOD AND DRINKS IN CABANA AREA OR ON TABLES ONLY (NOT CLOSER THAN 4 FEET TO POOL).
- REGISTERED RESIDENTS ONLY AUTHORIZED KEYHOLDERS MAY BRING UP TO 4 PRIOR APPROVED GUESTS, A SIGNED
 WAIVER FORM MUST BE ON FILE WITH THE HOA FOR EACH GUEST. NO PARTIES ALLOWED

NOT ALLOWED IN THE POOL

- NO ALCOHOL CONSUMPTION OR SMOKING IN POOL AREA OR CABANA
- NO STREET CLOTHES OR JEANS INSIDE THE POOL.
- NO BABIES WITHOUT SWIM DIAPERS. NO CHANGING DIAPERS EXCEPT IN RESTROOMS.
- NO RUNNING/ROUGH HOUSING, NO DIVING, SOMERSAULTS, FLIPS, CANONBALLS OR JUMPING OFF THE LEDGE.
- NO ABUSIVE LANGUAGE, LOUD MUSIC/EXCESSIVE NOISE.
- NO BIKES, SCOOTERS, SKATEBOARDS, MOTORIZED VEHICLES, LARGE TOYS, GAMES EQUIPMENT, NETS, BASKETBALL HOOPS, RAFTS, OR OTHER LARGE FLOATATION DEVICES.

IN POOL/CABANA/FENCED IN AREA AND PLAYGROUND

- NO BBQ GRILLS MAY BE SET-UP IN THE POOL/PLAYGROUND AREA.
- NO PERSONS WITH OPEN SORES OR INFECTIOUS DISEASES.
- TRASH MUST BE DISPOSED OF IN TRASH CONTAINERS.
- NO ANIMALS IN THE POOL/CABANA/PLAYGROUND FENCED IN AREA.
- DO NOT ALLOW UNREGISTERED PERSONS/ NON-MEMBERS ACCESS TO THE POOL/CABANA. VIOLATIONS WILL RESULT IN POOL USE SUSPENSION.
- NO VANDALIZING. NO FENCE JUMPING. VIOLATORS WILL BE PROSECUTED.
